NOTICE OF PETITION AND HEARING THEREON}

NOTICE IS HEREBY GIVEN that on the 13th day of February 2015 a Petition was filed with Mrs. Julie Wollerman, Ex-Officio Secretary of the Regional Board of School Trustees of Bond, Fayette, and Effingham Counties, Illinois; signed by Derek McAllister, Joy McAllister, and Milton Smith, II praying that the following described territory, to wit:

A part of the Northeast Quarter of the Southeast Quarter of Section 36, Township 8 North, Range 3 East of the Third Principal Meridian, Fayette County, Illinois, being more particularly described as follows:

Beginning at an iron pin (set) marking the Southwest corner of the Northeast Quarter of the Southeast Quarter of said Section 36; thence North 0 degrees 28 minutes 42 seconds East, (basis of bearings assumed) along the East line of the Northeast Quarter of the Southeast Quarter of said Section 36, a distance of 400.06 feet to an iron pin (set); thence South 89 degrees 56 minutes 12 seconds East, parallel with the South line of the Northeast Quarter of the Southeast Quarter of said Section 36, a distance of 367.66 feet to an iron pin (set); thence North 0 degrees 28 minutes 42 seconds East, parallel with the East line of the Northeast Quarter of the Southeast Quarter of said Section 36, a distance of 423.49 feet to an iron pin (set); thence South 89 degrees 56 minutes 12 seconds East, parallel with the South line of the Northeast Quarter of the Southeast Quarter of said Section 36, a distance of 264.10 feet to an iron pin (set); thence South 24 degrees 46 minutes 43 seconds East, a distance of 399.96 feet to an iron pin (set); thence North 82 degrees 23 minutes 06 seconds East, a distance of 487.67 feet to an iron pin (set) on the West right of way line of Illinois Route 128; the following 3 calls are along the West right of way of Illinois Route 128; thence South 0 degrees 28 minutes 30 seconds West, a distance of 470.42 feet to a concrete right of way monument (found), thence South 44 degrees 35 minutes 28 seconds West, a distance of 34.50 feet to a concrete right of way monument (found) thence South 0 degrees 28 minutes 30 seconds West, a distance of 30.73 feet to an iron pin (set) on the South line of the Northeast Quarter of the Southeast Quarter of said Section 36; thence North 89 degrees 56 minutes 12 seconds West, along the South line of the Northeast Quarter of the Southeast Quarter of said Section 36, a distance of 1261.25 feet to the point of beginning, as shown on the Plat of Survey dated October 20, 2008, prepared by Ricky R. Cox, I.P.L.S. #3031, situated in Fayette County, Illinois.
